

# RFP Pointers Puppy Purchase Agreement

RFP Pointers will notify Puppy Buyer within three days after birth of the litter. Please note, deposits will not be returned in the event that a puppy is not available for the sex Puppy Buyer has requested. However, the deposit will be transferred to another litter. Puppy Buyer will be given the opportunity to move to the end of the deposit list on available puppies of the opposite sex.

Puppy send home day will be the Saturday after the puppies turn 8 weeks old (unless notified otherwise). Puppies are picked in the order of deposit date. RFP Pointers does reserve the right of first pick.

RFP Pointers guarantees puppy has been examined by a licensed vet and has been deemed healthy. Puppy is up to date on shots and wormed. A record of all vet work will be provided at the time of sale.

If you are unable to pick up your puppy in person, we can help coordinate air shipping arrangements (pricing varies, typically \$450 to \$600). Temperatures during air shipment must be between 20 and 80 degrees during the duration of travel (Delta). One good option for people is fly out to pick up their pup and return with them in tow via carry on.

Puppy Buyer can return the puppy at Puppy Buyer's expense for a full refund if it develops an illness within three days of being picked up. Puppy Buyer must notify RFP Pointers immediately following diagnosis. Documentation must be provided by Puppy Buyer's veterinarian and will be reviewed by RFP Pointers veterinarian for concurrence. Puppy Buyer must return the puppy within 24 hours of notifying RFP Pointers of the puppy's illness with all registration paperwork and health records at Puppy Buyer's expense. RFP Pointers does not accept responsibility for contagious diseases diagnosed after three days from date of pick up. If during examination by Puppy Buyer's veterinarian a genetic issue is found and documented in writing by the examining veterinarian, the puppy may also be returned at Puppy Buyer's expense for a full refund.

If the genetic issue can be repaired and Puppy Buyer wishes to do so, RFP Pointers will reimburse Puppy Buyer up to the cost of the puppy. Any additional expenses will be the sole responsibility of Puppy Buyer.

Our puppies are guaranteed for 24 months for hips and elbow dysplasia, eyes and cardiac health, with Puppy Buyer's veterinarian documentation and RFP Pointers veterinarian reviewing and agreeing with the diagnosis. The guarantee is with puppy replacement not money replacement.

#### Responsibilities of RFP Pointers

RFP Pointers agrees to:

- Puppy comes with Full AKC registration option
- Puppy comes with Full NAVHDA registration option
- Dock the puppy's tail and remove the puppy's dew claws
- Administer first set of vaccinations and worming for the puppy
- Provide Puppy Buyer with a veterinary health check for the puppy

#### Responsibilities of PUPPY BUYER

Puppy Buyer agrees to:

- Maintain the puppy in good health as recommended by a licensed veterinarian. Puppy Buyer shall provide all proper immunizations, regular vaccine boosters, fecal exams, heartworm tests.
- Not spay or neuter the puppy until it is a minimum of 12 months old, if so desired.
- Keep the puppy in good mental and physical condition to help alleviate any health issues.
- Name the puppy with the prefix "RFP's" in the registration name

If, for any reason, Puppy Buyer can no longer care for the puppy, RFP Pointers shall be given the first opportunity to resume ownership, however RFP Pointers is not required to accept the puppy. If RFP Pointers resumes ownership the puppy will be returned with all of its registration paperwork and health records.

RFP Pointers is hereby released from any and all future liability to Puppy Buyer with regard to the puppy. Puppy Buyer agrees that from the date they take possession of the puppy, Puppy Buyer accepts all liability for the actions of the puppy and holds RFP Pointers harmless with regard to any and all third parties.

No other warranties or guarantees, expressed or implied, are made under this contract except as stated herein.
